

WARRANT TOWN OF WEST GARDINER

GREETINGS:

In the name of the State of Maine you are hereby required to notify and warn the voters of West Gardiner in said county, qualified by law to vote in Town Affairs, to meet at the West Gardiner Town Hall in said Town on Saturday the 21st of March AD 2020 at 8:00 a.m. in the morning then and there to act on the following articles to wit:

ARTICLE 1. To choose a Moderator to preside over said meeting.

ARTICLE 2. To elect all Town officers required by law and previous vote of the Town to be chosen by secret ballot. Namely: Excise Tax Collector/Town Clerk 3 Years, Selectman, Assessor, Overseer of the Poor - 3 Years, RSU #11 School Board Member 1 Year, and RSU #11 School Board Member - 2 Years in accordance with provisions of Title 30, Section 2061 of the Revised Statutes of 1964 and acts additional thereto and amendatory thereof. The polls will be open at 8:00 a.m. in the morning and closed at 12:00 noon.

The Business Meeting will open at 1:30 p.m. in the afternoon, March 21, 2020 at the West Gardiner Town Hall then and there to act on the following articles to wit:

ADMINISTRATIVE ACCOUNTS

ARTICLE 3. To see if the Town will vote to authorize the selectmen to spend up to 25% of the budgeted amount in each budget category of the current annual budget during the period from the beginning of the next fiscal year to the next annual town meeting or take any other action thereon.
